

RoHS III MATERIALS DECLARATION OF CONFORMITY

CBI-electric: low voltage certifies that their RoHS branded products, under the current directive conform to the requirements of the **European Parliaments Directive 2011/65/EU** and the amendments **2015/863/EU, 2018/739/EU, 2018/741/EU** (amendments of annex III), for the Restriction of Hazardous Substances in Electrical and Electronic Equipment.

CBI-electric: low voltage additionally declares that its products comply with the **European Parliaments Directive 2006/122/EC** for PFOS.

This declaration includes all components in the products assembly inclusive of where exemptions are applicable on specific components; such exemptions are noted in the table below.

Further to the above where VDE have certified our products as being compliant, the CE mark is applied in accordance to the relevant standards.
